Subject: Allocation of quota to CHGOs -regarding

Attention is invited to this Ministry's circular No. HAJ-15/5/2024-HAJ-MoMA dated 29.11.2024 publishing the list of eligible/ ineligible HGOs. Subsequently, this Ministry vide notice No. HAJ-15/6/2024-HAJ-MoMA dated 29.11.2024 has issued certain modifications in HGO policy for Haj 2025. Further, vide this Ministry's Notice dated 06.12.2024, CHGOs were mandated to submit application for up to 2600 seats wherein 2000 would be the confirmed quota (if the CHGO is registered) and remaining quota would be waitlisted.

- Subsequently, the Haj portal has been made live for Stage 2 registration from 04.12.2024. Based on the applications received from CHGOs on Haj portal along with hard copies of acknowledgements and other mandatory documentations, Ministry has issued registration and allocation certificates to eligible CHGO applicants and constituent members for Haj 2025 as per Annexure. 52,000 seats out of total quota for HGOs of 52,507 have been distributed among 26 CHGOs as 2000 seats each.
- 3. As per the MoUs submitted by 26 CHGOs, 153 HGOs have been opted as waitlisted members by them.
- Now, with the approval of the competent authority, in supersession of the earlier conveyed. 4. policy for distribution of residual quota issued vide Ministry's notice no. HAJ-15/5/2024-HAJ-MoMA dated 06.12.2024, and in order to ensure that all waitlisted HGOs are allocated quota, it has been decided that the remaining quota of 507 is be distributed as under:
- (i) initially a quota of 3 each will be distributed to all the waitlisted HGOs (153 x 3= 459) and;
- (ii) the remaining quota of 48 pilgrims will be distributed with 1 seat each being allocated to the waitlisted HGOs on a 'first come first serve' basis as per the time stamp of online submission of the corresponding CHGO application during Stage-2 and the priority order of the waitlisted firm in
- Further, the Ministry is proactively seeking the allotment of additional quota from KSA. In case of additional quota being received, the quota would be distributed as under:-
- (i) On a pro-rata basis up to 50 seats for all the HGOs waitlisted as on date.
- (ii) Policy for distribution of quota beyond 50 seats to each waitlisted HGO, if quota is still available, would be communicated subsequently.
- This issues with the approval of the Competent Authority.
